How to Use VersaLock® Tamper Evident Feature:



1 Sealed package corner lid tab indicates that package has not been tampered with



2 Pushing down on corner tab breaks seal



3 Broken seals and raised tab indicate that container has been tampered with



4 Lifting up on tab while pushing down on base side opens container

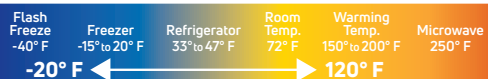
D&W utilizes the most modern and state-of-the-art PCR extrusion process to convert PCR into high quality FDA approved food packaging.
